Limited Liability Partnerships (LLP) LLPs must turn in a Limited Partnership Certificate and elect to be formed as an LLP within the state. Form 3 A partnership must annually report the partnership's income to the Department of Revenue on a Form 3, Partnership Return of Income if: It has a usual place of business in Massachusetts, or; Receives federal gross income of more than \$ during the taxable year. Although no tax payments are made with the Form 3, the partnership is subject to penalties for failure to file or late filing of this return. To form a partnership in Massachusetts, you should take the following steps: Choose a business name. File an assume business name. Draft and sign a partnership agreement. Obtain licenses, permits, and zoning clearance. Obtain an Employer Identification Number. Note: Citations are based on reference standards. However, formatting rules can vary widely between applications and fields of interest or study.
